3. Filing fee for this form is \$20.00 per document. New fee of \$20.00 is effective 7-1-91. If the space provided for any item on the form is inadequate, the item should be continued on additional sheet not exceeding 8 1/2 x 11 inches. Staple once in upper left corner. Do not attach a cover or backer. Debtor and secured party's name must be typed above/below the signature line.
4. Make check payable to Bureau of Conveyances for fees.

2. Send the original to Bureau of Conveyances, P.O. Box 2867, Honolulu, Hawaii 96803. It will be returned after recordation. (One sheet without carbons.) Enclose self-addressed, stamped envelope.
3. Include recording fee of \$25.00 for each document. This covers first 20 pages. After 20, each add'l page \$1.00. Make check to Bureau of Conveyances.
4. If the space provided for any item on the form is inadequate, the item should be continued on additional sheets preferably 8 1/2 x 11, but in any event not exceeding 8 1/2 x 11 inches.
5. Do not write in blank 3 1/2" space at top of the form. Completion of item 1 is optional. Debtor and secured party's name must be typed above/below the signature line.
6. Complete item 5 on front side or document will be rejected. Original book and page or document number of financing statement referenced to is required.
7. Fees on UCC3 (request for information - copies) are \$25.00 per search plus \$5.00 per name for each name listed, and 1.00 per page on copies. One debtor per form and separate request and fee if dba.
