Filing The UCC-1 form is filed at the state UCC office. An original filing must be signed by the debtor subject to the four exceptions in item 2. Remove the PINK copies and send the two WHITE (Secretary of State) copies with the top stub still intact to the Uniform Commercial Code Section.

Termination When using the UCC-1 acknowledgement copy to terminate make sure the correct mailing address is reflected in item 4. When the security interest is satisfied, the secured party may date and sign the termination statement on the UCC-1 acknowledgement copy and submit it in duplicate (photocopy) to the filing officer. In addition, a UCC-3 form may be used to terminate. When using a UCC-3 form to terminate, refer to the original filing number in the space provided.

Item Instructions

1. Type the debtor's legal name, address, and social security number (individual) or federal tax I.D. number (business) as used on state and federal income tax forms. Always type the social security number or federal ID number on the lines provided next to the corresponding debtor name.
2. **MARK ITEM 2a, 2b, 2c, or 2d WHEN THE SECURED PARTY IS SIGNING INSTEAD OF THE DEBTOR - Only the debtor must sign the financing statement, and the signature of the secured party is not necessary, except that the secured party alone may sign the financing statement in the four (4) instances corresponding to the check boxes in item 2 on the face of this form. 5. Item 5 is used to indicate the number of additional sheets not counting the UCC-1 filing form. If additional space is needed for any items requested on this form, continue the items on separate sheets of paper (8 1/2" X 11"). Duplicate copies of the additional sheets are not required. USE PAPER CLIPS to attach these sheets to the form (DO NOT USE STAPLES, GLUE, TAPE, ETC.) and indicate the number of additional sheets attached in item 5.
6. Type the State Billing Account number assigned by the Secretary of State, if known. This number is used for billing purposes for users with accounts.
7. Mark the appropriate check box if products of collateral are covered.
Mark the appropriate check box if the debtor is a transmitting utility. A transmitting utility filing does not expire until a termination statement is filed.

A UCC-3 filing is filed in the same office as the original filing. When filing at either the county or state office, the filing must be signed subject to the signature requirements below. For state UCC filings, send the filing officer copies to the Uniform Commercial Code Section. For county filings, send the filing officer copies to the appropriate Register of Deeds office. If land is located in more than one county, a separate form must be filed in each county. Remove the PINK copies and send the filing officer copies with the top stub still intact to the state or county office.

Termination When the security interest is satisfied, the secured party may date and sign the termination statement on the UCC-1 or UCC-1A acknowledgement copy and submit it in duplicate (photocopy) to the appropriate filing officer. Partial Release - requires the signature of the secured party.
Termination - requires the signature of the secured party.
