INSTRUCTIONS

HOW TO FILL OUT FORM PLEASE TYPE

- BOX 1:** Use mailing address of Debtor. If the Debtor is a transmitting utility, check the box.
- BOX 2:** Use the address of the Secured Party from which information on the security interest may be obtained.
- BOX 3:** Do not write in Box 3.
- BOX 4:** If the space provided is inadequate, the item(s) should be continued on additional sheets, preferably 5" X 8" or 8" X 10". Only one copy of such additional sheets need be presented to the filing officer. Indicate the number of additional sheets in Box 11. Long schedules of collateral, indentures, etc. may be on any size paper convenient to the Secured Party.
- MOBILE HOMES IN MAINE:** The description must include the location of the mobile home as indicated in the security agreement. See 9-402.
- BOXES 5, 6 & 7:** See 9-402. If the collateral is any of the items in Box 6, i.e. (a) crops, (b) fixtures or (c) timber, etc., check the appropriate box and describe the real estate in Box 7. If the Debtor has no interest of record in this real estate, complete Box 5 - - EXCEPTION: a filing for crops in New Hampshire does not require Box 5.
- BOX 8:** New Hampshire: Check this box if either Box 6(b) or (c) is checked. Maine: Check this box if Box 6(a)(b) or (c) is checked.
- BOX 9:** If the Financing Statement is signed by the Secured Party instead of the Debtor, state in Box 9 the applicable reason, which may be any of the following: ". . . Collateral:"
(a) already subject to a security interest in another jurisdiction when brought into this state; (b) already subject to a security interest in another jurisdiction when Debtor's location changed to this state; (c) which is proceeds of the original collateral de-

scribed above in which a security interest was perfected; (d) acquired after a change of name, identity or corporate structure of the Debtor; or (e) as to which the filing has lapsed. See 9-402(2).

BOX 10: Indicate all offices where form is to be filed.

BOX 11: See instructions for Box 4.

ASSIGNMENT: If this is an original filing for a security interest that has been assigned, you may either show the assignee as the secured party or show the original secured party and type the word "Assignee" and the name and address of the Assignee immediately below Box 3. Otherwise use the UCC-3 Form. See 9-405(1).

LEASED OR CONSIGNED GOODS: Substitute "Lessor" or "Consignor" for "Secured Party" and "Lessee" or "Consignee" for "Debtor", if applicable, wherever they appear. See 9-408.

FILING INSTRUCTIONS

- A. Remove Secured Party and Debtor copies and send other 3 copies with interleaved carbon paper to the filing officer. Enclose filing fee.
- B. Fold only along perforation for mailing.
- C. When a copy of the security agreement is used as a financing statement, send a completed but unsigned set of these forms with it, without extra fee.
- D. At the time of original filing, filing officer should return third copy as an acknowledgment. At a later time, Secured Party may date and sign termination legend and use third copy as a Termination Statement.
- E. When filing is to be with more than one office, Form UCC-2 may be placed over this set to avoid double typing. New Hampshire only.

HOW TO FILL OUT FORM PLEASE TYPE

- BOX 1:** Use the mailing address of Debtor as on the UCC - 1. If Debtor is a transmitting utility, check the box.
- BOX 2:** Use the address of the Secured Party from which information on the security interest may be obtained.
- BOX 3:** Do not write in Box 3.
- BOX 4:** Self-explanatory.
- BOXES 5 & 6:** If the original financing statement was filed for record in the real estate records, check Box 5, describe the real estate in Box 8, and give the name of the record owner in Box 6, Sec. 9-401(1) and 9-402(5) of UCC.
- BOX 7:** If the space provided for any item(s) is inadequate the item(s) should be continued on additional sheets, preferably 5" X 8" or 8" X 10". Only one copy of such additional sheets need be presented to the filing officer. Indicate the number of additional sheets in the Box.
- BOX 8:** Select and check the appropriate purpose of the form in Box 8. If additional information is required, use the space in Box 8 below the list of purposes.

ASSIGNMENT: If an assignment has previously been made, the assignee is now the secured party of record and must sign this. If this Financing Statement Change is signed by a person other than the secured party of record, it must be accompanied by a separate written statement of assignment, including payment of the required fee.

LEASED OR CONSIGNED GOODS: If this is a filing pursuant to Sec. 9-408 of the UCC, substitute "lessor" or "consignor" for "secured Party" and "consignee" or "lessee" for "Debtor" as appropriate.
