INSTRUCTIONS FOR UCC-1 FINANCING STATEMENT

1. THIS STATEMENT MUST BE TYPED.
2. Enclose correct filing fee. Financing Statement fee is \$10.00. Financing Statement with Assignment fee is \$20.00. If filing at County level there is an additional fee of 50¢ for each additional page over two.
3. If filing at the State level you are required to submit only the top, original sheet "(1) Filing Officer Copy - Alphabetical" to the Secretary of State's office. If filing at the County level you are required to submit the top 3 copies with interleaved carbon paper to the Register of Deeds. These are designated "Filing Officer Copy". Remove Secured Party and Debtor copies.
4. If the space provided for any item(s) on the form is inadequate, continue on additional sheets of 8 1/2" x 11". One copy of such additional sheets must be presented to the filing officer along with a set of three copies of the financing statement.
5. If collateral is crops or goods which are or are to become fixtures, describe generally the real estate and give name of record owner.
6. When a copy of the security agreement is used as a financing statement, it is requested that it be accompanied by a completed but unsigned set of these forms, without extra fee.
7. At the time of original filing, officer should return third copy as an acknowledgment. Later, secured party may date, sign and use third copy as a Termination Statement.
8. When not a money obligation, instrument is taxable on value of property covered.

1. THIS FORM MUST BE TYPED.
2. Enclose correct filing fee.
3. If filing at the State level you are required to submit only the top, original sheet "(1) Filing Officer Copy-Alphabetical" to the Secretary of State's office. If filing at the County level you are required to submit the top 3 copies with carbon paper intact to the Register of Deeds. These are designated "Filing Officer Copy". Remove Secured Party and Debtor copies.
4. If the space provided for any item(s) on the form is inadequate the item(s) should be continued on additional sheets of 8½" x 11". Only one copy of such additional sheets need be presented to the filing officer with a set of three copies of Form UCC-3.
5. At the time of filing, the filing officer will return third copy as an acknowledgment.
